# CONTRACT # 2 IN SAN FRANCISCO!

After approximately a month of negotiations between management at Professional Messenger and a committee of employees, a contract to be ratified has been agreed upon. gains affect different portions of the company uniformly and differently. medical benefits move from 25% paid by the company to 50%. Afloating holiday at the employees discretion has been added. a 401K plan will be developed. Paid time off will be extended to all, an increase over the bargaing unit of roughly 50%. an additional day off has been added bringing the total package to 9 days off for those employeed over 31 months. there are incremental increases and the plan starts after 6 months with 16 hours offered. bike messengers will recieve a maintenance allownace of \$600.00 per year not to exceed \$50.00 per month. Owner-vehicle drivers recieve a \$100.00 per month allowance to cover parking and bridge tolls. The

gate fees for company vehicle drivers have been eliminated. This amounts to the removal of an illegal system that charged drivers \$30.00 per day. most discounts were eliminated and a radical new per hour system will be utilized when our contract begins. we worked very, very hard and feel optimistic that Professional Messenger shall now become a dignified place of employment.

ollow up: Just in case it wasn't clear, the support from the messenger community is beyond measurement. when I said we've worked hard for this contract, I had you people in mind. it should be stated that pro-mess attempted to put some of their shit right when they got a whiff of what they might be dealing with, namely a union. A significant bonus(in reality, a cut back to us from the company's bloated profit tag %) that put us up to speed with other companies, legit jerseys, rain-day bonus, and paid time off. The contract is for one year because the increases we were looking at could not be deemed serious. We locked down what we have with minor increases in tag % and some pretty good packages depending on what segment of the company you are in. The most significant

gain, I believe, was to bring p.t.o. to those who had been with this sweat shop for x + years and never had any. early in this drive people would phrase questions in a format beginning with "what is the union..." the union, I began to believe, is not a force outside any one of us, the union is any group of like minded individuals attempting to stop exploitation. Yes, ILWU local 6 has many agendas, one of which now is protecting it's newest members: the couriers of speedway and professional messenger.


## MOUNTAIN LION 2000 on July 22, 2000 was won by Matt "Broiler" (who else ?)



#### RILEY SPEAKS TO THE SFBMA

At July's SFBMA meeting Ken Riley, President of International Longshoremen's Association (ILA) Local 1422 in Charleston, South Carolina, spoke about the struggle of his union against a Danish shipping firm AND the state of South Carolina. Before his speech he presented a list of Charleston Messenger companies to the SFBMA.

Earlier this year the Danish shipping firm Nordana sent a ship to Charleston, the USA's 4th largest and most productive port. Nordana hired a non-union crew to unload their ship and then sent another ship in to be unloaded by non-union workers. This was an attempt by a foreign multinational to impose lower working standards on the longshore workers of South Carolina. By using non-union dock workers, Nordana could begin to drive down wages and working standards not only in Charleston but all along the Atlantic and Gulf Coasts.

The longshoremen of Charleston did not neglect their responsibilities. Under Ken Riley's leadership they organized protests and were joined by the longshoremen of Houston who refused to unload a Nordana ship. Their actions were noticed by the Republican Party of South Carolina. On January 20, when the longshoremen gathered for a 3rd protest against the foreign ship, police clashed with the dock workers. Although the state of South Carolina supported the foreign corporation against its own citizens, the shipping firm backed down and committed to hiring ILA members at proper working standards and wages. Nevertheless the Republican Attorney General of South Carolina charged 5 longshoremen with such crimes as "conspiracy to riot". A local judge threw out all charges so the AG found another judge to accept the political charges. In the honored cus

tom of noting that "An injury to one is an injury to all", Ken Riley and ILA 1422 have raised money for the legal defense of their brothers on the line. Our ILWU has contributed over \$ 50,000 (and counting) to the legal defense.

Ken Riley's speech highlighted these points and SFBMA members responded with almost \$ 300 in donations to the legal defense fund.

As we see, more people are building alliances to resist the Multi-National Corporations worldwide attack against democracy, the environment and worker's rights. We in the SFBMA have joined these efforts with our conferences with Muni Drivers.our unity with other Messengers in the CMWC, our own Union activism and now with our solidarity with the Longshoremen of South Carolina. Because our resources of money and time are still small, we must lead with our heads as well as our hearts in such matters. By supporting people who are standing up against a multi-national AND the armed forces of the extremist state of South Carolina, I believe we are taking an action that honors the thoughts of our heads and the sympathies of our hearts.
