### HAVEN'T WE BEEN HERE BEFORE?

The owner of ProMess, intrepid Napoleonimitator and delusional philanthropist Joel **L** Ritch, is up to his usual mischief. Those of us who have been involved in union organizing at ProMess must be naïve-we keep being surprised by each new misdeed and deceit of Joel and his coterie of battle-droid managers. Joel has declared war on the very messengers who paid for his Cadillac and his nice big house on Buena Vista Park. So now we have to open up a frosty can of whoop-ass just to protect what we've got, let alone make anything better.

The latest word from the streets on May 29 is that ProMess bought (or merged with) Silver Bullet. Some sources report that Bullet riders were invited to report to work at ProMess on Monday, June 3rd as non-union workers. This was of course a surprise to Pro employees who have been members of ILWU Local 6 since summer 2000. We don't know whether the Silver Bullet employees are being brought in as scabs and union-busters in case of another strike, or to vote with the company in another union election which may or may not happen. There are, however, two questions that press themselves to the minds of many:

- 1) How is it that Joel can afford to buy another messenger company when he's been telling us in contract negotiations for months that there's no money for raises?
- 2) One Silver Bullet driver was Pro's old Human Resources guy Ernie Foxman. Can he bear to work for Joel again?

The Silver Bullet thing is just the latest bit of dookie from ProMess. For one thing, they've been paying employees for weeks to drive around in company trucks to pass a petition to get rid of the ILWU. Many of the people who did sign were deceived or intimidated into it.

So on Tuesday, the day before the Silver Bullet news, Pro's lawyer Rob Hultang of Littler, Mendelson called the ILWU to cancel contract negotiations and claim that their decertification petition was valid, without offering to produce it for verification. (I don't want to say that Rob is ugly, but if you puked on his head, no one
